spot for all CUPE 4153 Caretaking and Maintenance staff. This was very helpful for members to locate any needed

reference material, and it was in black and white – not "well I think the Board sent out an email a while ago about

that?". Good news!, we are on the way back to getting everything under one roof again, well, it is actually going

to be two roofs – some of the documents are best suited on eBase, these documents will be more for day to day

operations...and the second roof will be under the Facilities Management/Facilites Operations section of the

Board's SharePoint website. There have been several documents already uploaded to the site, they are listed (for

the time being) under the "Documents" section of the Facilities Operations main page. For now, we can refer to it

as the "FM (Facilites Management) Index". Board documents of a similar nature are grouped into files with a

general category title – ex. anything related well water would be located in the file "Water Systems", or anything

related to fire safety will be in the file "Fire Safety", etc. Click on the folder to investigate the contents. We
