Nominations will be taken at Sunday's Membership Meeting as well as by email from Sunday morning at 10am until Wednesday at 4pm. Email nominations will need to include the following information: Name of the member being nominated, position(s) being nominated for and name of the member nominating them. As an example – "Blake Corkill is nominating Mark Lachowicz for the position of Health and Safety Committee". Nomination emails should be sent to <a href="mailto:cupelocal4153@bellnet.ca">cupelocal4153@bellnet.ca</a> before the deadline of Wednesday May 18<sup>th</sup> at 4pm.

Emails to members advising them that they have been nominated for positions and asking for a response to accept or decline their nominations will go out Thursday morning and responses will be due back by email by 12 noon on Monday the 23<sup>rd</sup>. Lack of a reply within the timeframe above will be considered a decline of nominations.

Tuesday May 24<sup>th</sup> we will publish a list of all candidates for positions on our local website and all candidates may begin to submit their election letter/material. Materials should be kept to one letter sized page and focus on the candidates positive traits and characteristics. Any negative material will not be approved by the Election Committee. Once approved, all election materials will be posted on the local website for members to view up until the day of the election.

Voting will take place on June 23<sup>rd</sup> from 8am – 5pm by electronic vote only. Electronic voting has increased participation by members in previous votes and has had very few issues, so the committee has decided to continue on with that. Mark Lachowicz asked Patrick Cumbo about the 2-strike fund savings account why are they not deposited into the account already? Patrick Cumbo said I missed the date to transfer this money. This account we can take money out, but we can't deposit until the maturity date. Just so everyone is aware no monies have been used from this account. We should have \$300,000,00 dollars by the end of August 2022 in this account.

Robyn Archibald asked Patrick Cumbo what happen to the money if we do not go on strike? Patrick Cumbo said it stays in there and collects interest and grows.

Frank Aloisio asked Patrick Cumbo when is the extra \$5.00 dollars going to stop coming off our pay? Patrick Cumbo said at the end of August 2022.

Blake Corkill said the local contributes \$5100.00 dollars to the strike fund. Blake Corkill said if Doug Ford is elected again it is going to go one of two ways, our wages are going to be capped again at 1% or they are going to have a wage freeze. We need to vote this guy out. The strike fund account is to be used to keep our doors open at the office and we can pay our members 5 weeks of strike pay. Bill 124 comes to an end at the end of June.

Dave Dickhout said all executive and stewards will not get paid per diem that will end during a strike.

Sam Salvo asked who pays for the health and safety book off. Patrick Cumbo said the board pays for all the health and safety book off.

Patrick Cumbo said please forward your emails when you book off for union business to Janna Thomson.

#### WSIB/Wellness report – Patrick Cumbo

Patrick Cumbo the wellness team we have a lot of members taking time off and remember that when you submit your FAF form it does not mean you will go to work that day or the next day. If the wellness receives the FAF with no restrictions then you will get an email from the wellness team saying welcome back and you can return to work, but if you have restrictions then there must be an accommodation meeting with the wellness coordinators. This usually takes 3-4 days. If you have not heard from them within 24 hours, please contact one of us. The board is saying we are averaging 145-150 people a day off. We are having issues with coverage; we have some members that call in 10 -15 minutes before shift and no one will pick up that job. When this is done it hurts the caretakers at that building. As Peter Bowker said members are calling in after their shift has begun, and the board is handing out letters of expectation or direction notices. They are coming down hard. They are having private investigators tracking down covid 80 and people are supposed to be isolating not going to the mall, shopping, golfing. We don't recommend you do this. Bob Avery is monitoring this issue. They have the right to share your personal information with a third party if they feel you are abusing the sick time. We have checked into this, and they are allowed to do this. It is every group that works for HWDSB not just CUPE. Peter Bowker said this will end in termination.

Patrick Cumbo said if you get injured at work make sure you fill out the accident report, the doctor will fill out paperwork as well or the hospital. You are responsible for paperwork to be filled out not the FOS. WSIB don't fool around if you don't give them the right paperwork that is required you can be denied your claim. There are forms on our website and if you need any help, please contact the Wellness/WSIB committee.

Danny Catanyag said I have a problem when the board uses recording device or surveillance on any member, they should have to inform all the locals that they may be under surveillance. Patrick Cumbo said this has been a long-standing practice with the board they are one step away from having private investigators on retainer. Our sick days are a paid benefit and when our members are abusing that they have the right to give out personal information to confirm or deny that the member is abusing the benefit.

Laurie Penner asked why my FOS has not told anyone that I have accommodation they will make you an IEP and you need to bring that with you when you change schools. Patrick Cumbo said they are not to disclose this information it is private and confidential. They may have a meeting with the other caretakers to split your duties, but the other caretakers have no right to your personal information.

Paul Large said what if you have a doctor's appointment. Patrick Cumbo said to try and make it after work hours or take a vacation day.

Patrick Cumbo said Jamie Nunn is aware of the issues we face with the wellness department, I told him you complain about our absenteeism when it takes your department 5-10 working days to get back to members that have handed in there FAF forms and are ready to come back to work.

# Cleaning of Droppings

CODE: C - 17

ISSUED: Date 2018

Page **1** of **2** 

#### 1. Purpose

To outline the safe cleaning process for droppings in HWDSB buildings.

#### Scope.

Applies to all types of droppings such as: mouse, bat, bird.

**Note:** Any concerns about the clean-up of droppings are to be made to the Facilities Operations Supervisor. For areas that have nesting or may be an infestation, Caretaking staff are to submit a Priority 2 work order for the area to be inspected by the Regulated Substance Team.

#### 3. Responsibility

#### **Facilities Operations Supervisors (FOS)**

- Ensure that all caretaking staff receive information and instruction on:
  - Safe work practices for the clean-up of droppings
  - o Use, care, and disposal of personal protective equipment (PPE)
  - Hand hygiene

#### **Caretaking Staff**

Clean up droppings in accordance with this procedure and utilizing the PPE outlined

#### Regulated Substances Team

 Respond to and provide cleanup for nesting and infestations utilizing the PPE outlined in this procedure

#### 4. Procedure

#### Caretaking staff:

- a) Any employee performing these duties must wear disposable protective gloves.
- b) Areas with mouse droppings must be sprayed with the board approved disinfectant. Make sure the droppings are fully saturated. Let it soak for 5 minutes.
- c) Use a disposable dampened cloth to move the droppings into a plastic garbage bag.
- d) Dispose of the disposable cloth in the same plastic bag, seal and remove directly to the dumpster.
- e) Spray the area again with the disinfectant for at least 5 minutes.
- f) Remove gloves, and thoroughly wash hands with soap.

#### Regulated Substances Team:

Where the FOS believes there may be an infestation or nesting:

- a) Separate the work area by means appropriate to keep occupants of the building out of the work area.
- b) Communicate with the main office/Head Caretaker of the work being performed at the site.
- c) Ensure that a NIOSH approved half mask respirator equipped with a P100 cartridge, Tyvek suit, nitrile gloves and Tyvek booties (over footwear) are worn while performing this task.

- d) Clean and disinfect the area. This may be by means of HEPA vacuuming, wet wiping, or wet sweeping.
- e) Scrape / broom material into a plastic bag.
- f) Seal the bag, double bag, and remove directly to the dumpster.
- g) Immediately upon completion of the task, while still wearing disposable gloves, wipe down the entire suit with a solution of water and appropriate disinfectant material.
- h) Remove the suit and booties, while still wearing the disposable gloves and place in a6 mil poly bag.
- i) Remove gloves and place in the 6 mil poly bag with suit. The bag will be sealed and disposed of as per Supervisor's direction.
- j) Use an alcohol-based hand rub or wash hands with soap and water after removing the gloves.
- k) Remove the respirator. To minimize contamination, avoid contact with the respirator and when removing touch only the straps. Damp wipe and thoroughly clean respirator with a solution of water and appropriate disinfectant after removal.
- l) Immediately upon completion of this work, wash hands thoroughly with warm soapy water.

#### 5. Precautions/Special Instructions

- Never sweep or vacuum dry droppings as the airborne dusts can cause illness. HEPA vacuuming, wet wiping or wet sweeping are the accepted methods of removing droppings.
- Eating, drinking, chewing or smoking shall not be permitted in the work area
- If there is nesting, it has been determined that there is an infestation by the FOS, the area will be cleaned by the Regulated Substance Team.
